Express Window Films, LLC warrants professionally sold and installed Express brand window films against product failure such as peeling, bubbling, cracking, adhesive failure, delamination and demetalization per the limits expressly stated within this warranty. See "Product Warranty by Series" chart for warranty coverage terms. Residential or Commercial coverage starts from the date the Express Window Film was installed, extends to the original buyer, is not transferable and is only applicable on interior vertical glass installations in the USA and Canada. Express Window Films warranty liability is limited to the replacement and re-installation labor of only such quantity of window film found to be defective under this limited product warranty. This warranty does not include coverage for fade or change of color of any interior items or furnishings. Installations over 2500 square feet must be pre-approved in writing with authorization code provided by the Express Window Films warranty service department prior to installation for this product warranty to be valid.

There are no warranties which extend beyond that which is described above. Express Window Films warrants the window film product only and does not warrant against improper application of the films, poor installation technique, contamination, improper or inaccurate measuring and/or trimming. There is no coverage for any loss or damage caused by cleaning abuse and/or any non-complying uses of the film. This limited product warranty does not include coverage for (TSF) Thermal Shock Fracture or (IGU) Insulated Glass Unit seal failure.
